ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Syed Barey Educational and Charitable Trust, Gulbarga, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Hameed Piyare College of Education, No 7-95, Barey Manzil, Mominpura, Gulbarga District, Karnataka for Secondary(B.Ed) Course of one year duration from the academic session 2005-06 with an annual intake of 100 students.

- On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - The institution has acquired the land for setting up the teacher education institution.
 - b. The institution has made arrangements for conducting the course in the rented premises.
 - c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 lakhs.
 - d. The institution has selected the <u>Principal and Seven</u> lecturers for the said course and the list of faculty members has been approved by the affiliating University.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Hameed Piyare College of Education, No 7-95, Barey Manzil, Mominpura, Gulbarga District, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students subject to fulfillment of the following.
 - a. The institution will ensure that <u>Principal and Seven</u> faculty members duly approved by affiliating University are in position for an intake of <u>100</u> students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.

- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
- The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
